The first day provides an opportunity to assess how digitalisation created a new experiential concept about learning and mental health. Discussion will focus on how students and lecturers adapt to a digital form of learning and teaching and a new paradigm becomes part of everyone's primary and secondary identity. This session will also discuss how assessments have been transformed into higher. In the second part of the program, we will focus on the mental health characteristic of online learning and digitalisation. Here, we look at different supports and provisions that, or the lack of it, might have been available during the height of the pandemic. This part of the session will focus on the implicit and explicit feature of mental health.

## DAY 2: APRIL 21st

The cost of COVID-19 is axiomatic. Providing a platform with the aim of discussing the consequences of COVID-19, on this second day, we will talk about how the pandemic created a vacuum on equality, accessibility, and possible missed market opportunities. The purpose is to gain an understanding of the complex result of the pandemic and the need for a collaborative and multilateral engagement. In the afternoon, specific details regarding the cost of COVID-19 will be examined and how to solve the chronic problem that has been looming since lockdown. This includes support provision for international students, the zeal of COVID-19 graduates to join the labor force, the robustness of academic output in an e-learning environment, and the availability of face-to-face internships to bridge the gap between academic theories and their practical traits.
